The map data contained in the V&M app is downloaded from a third-part program and therefore the information presented may not be accurate.

The user must also take responsibility for the users own actions and put own safety and wellbeing first and foremost.

The MIS V&M application is intended for use by people who have limited or no visual ability and who use navigation tools on their own.
